Hello Vivian,

As we discussed on the phone today, you may join the board of a Political Action Committee (PAC) as a County employee, but you should be aware of some of the restrictions placed on government workers under County policy and State law.

In essence, you may freely engage in political activities outside the workplace but should not attempt to coerce coworkers about your political positions while on the job.

See the attachments, Administrative Order 7-2 and the Little Hatch Act, Fla. Stat. 104.31 (2010), for a more complete discussion.
