Ms. Uppal,

As we discussed today, Ana Martinez, who is employed by United Way, has a conflict that prevents her from serving on a selection committee to review the Special Transportation System RFP.

A selection committee member must perform her duties to the County free of the perception that her independence of judgment is impaired. (See County Code at Sec. 2-11.1 (j).) Because Ms. Martinez's employer has received a donation from Zuni Transportation, a named subcontractor of one of the bidders, it would not be unreasonable for some citizens to question whether Ms. Martinez's decisions favor that bidder.

Ms. Martinez may serve on other selection committees as long as the bidders have no associations with her or her employer.
