## Hello Aimee.

In response to your question below, a County employee may accept the gift of a weekend trip to Orlando from TicketsAtWork and Coco Key Hotel and Water Resort. We understand that neither entity is a County contractor, vendor, service provider, bidder or proposer. Consequently, Section 2-11.1 (w) of the County Code, which prohibits accepting travel expenses from County vendors, is not implicated.

Additionally, the opportunities to network at the event may enhance discounts for County employees and thus serve a public purpose by reducing the cost of benefits to government employees overall.

Please be advised, however, that County employees may never accept a gift in exchange for taking a public action, carrying out a legal duty or violating a legal duty. (*See* Miami-Dade County Code at Sec. 2-11.1 (e)(3).) Additionally, a gift valued at over \$100 must be reported on a gift disclosure form as per Miami-Dade County Code at Sec. 2-11.1 (e)(4).
