I received an inquiry from Human Resources Director Mary Lou Rizzo regarding a proposal from United Way to provide workshops for County personnel managers through their Center for Financial Accountability. The workshops, funded through a grant to United Way by Wells Fargo, which was supported by the Mayor of Miami-Dade County, would include lunch provided to the personnel managers. The overall purpose would be to educate the managers in the financial accountability programs offered by the United Way, for referrals of county employees to those services.
