Ms. Gachelin,

You are not allowed to seek donations from County employees on behalf of Mikael's Helping Hands, a private foundation you have established. Additionally, you are not allowed to use any County resources, including the County email system, in an effort to transmit information about the foundation.

Under the County Code at Sec. 2-11.1 (e)(2)(g), *only* County Commissioners and their staff may solicit donations on behalf of nonprofit 501(c)(3) entities. Typically, solicitations on behalf of 501(c)(3) entities are made following a directive or resolution by the County Commission.

We understand that Mikael's Helping Hands Foundation has not been granted 501(c)(3) status from the IRS.

If you wish to inform County workers about Mikael's Helping Hands in the future, I suggest you first obtain 501(c)(3) status and then seek the assistance of a County Commissioner to support your efforts within the County.
