Councilman Harris,

As we discussed today, the County Ethics Code does not prevent you from using your discretionary office funds from the City of Miami Gardens to purchase refreshments for a government-sponsored event.

We understand that you receive public funds from the City of Miami Gardens in your official capacity as a Miami Gardens council member. You have complete discretion to use the office funds for any legitimate public purpose.

A legitimate public purpose would include providing refreshments for a "Teen Focus Group" event to be held in Miami Gardens and designed to build relationships between local teens and law enforcement. The event is being sponsored by the Office of Prevention and Victim Services, a division of the Florida Department of Juvenile Justice (DJJ). You are employed as a senior probation officer with a different division of the DJJ. You will not personally benefit or be enhanced by the donation you are making to the event using city funds.

Since not all donations may serve a valid public purpose, in the future you may wish to obtain the approval of your city council before expending city funds on activities that may be questioned. Additionally, feel free to call our office if you would like to discuss these matters further.

This is in follow up to our conversation in reference to the Florida Department of Juvenile Justice Youth Focus Group.

The Department of Juvenile Justice, Office of Prevention and Victim Services has scheduled a Teen Focus Group to be held December 13, 2012 at the JPM Centre, 3:00pm to 5:00pm, 4055 N.W. 183rd Street, Miami Gardens, FL.

The teen focus group is designed to provide a solid foundation for youth to foster a more positive relationship with law enforcement and to create a well-balanced understanding by law enforcement of today's youth. One major premise is to promote reduced juvenile arrest and rearrests. Often times the focus is on punishment and very little on prevention and intervention. The Teen Focus Group will allow us to explore and identify factors that at risk youth are exposed to and then apply early intervention before at risk youth enter the juvenile justice system. We are focusing our practices on **preventing** and **diverting** youth who do not belong in our system.
