## Vice-Mayor Watts,

You asked if Village Commissioners and/or citizens may editorialize in the Village Newsletter, which is published with government funds. These questions fall within the Florida Sunshine Law at Fla. Stat. Sec. 286.011 and are best answered by your Village Attorney. The County Ethics Commission is not empowered to interpret state law.

Unquestionably, you and another commissioner may not debate Village business in the Village Newsletter outside of a duly noticed public meeting. Appointing citizens to engage in the editorial debate rather than the commissioners themselves may not be a solution either. Again, your Village Attorney will advise you on these limitations.
