Ms. Collazo,

Please recognize that this is only an informal opinion generated immediately due to the urgency of your request. A definitive opinion, should you want one, would need to come from the Commission on Ethics and Public Trust at a public meeting.

It is my position that ticket(s) or any item of value donated or given to a public entity in the name of that entity is public property, and, as such, is subject to the same restrictions and analysis as tickets gained by the public entity through a contractual process. Therefore, if the tickets in question have been given to the County as an entity, and not specifically to any individual, they should be disposed of in accordance with the public purposes guidelines in our most recently adopted internal memo (attached).

In the event that the tickets have been personally designated to be given to any particular official and the official accepts them, they become a reportable gift if they are valued in excess of \$100. The only exception to that would be a ticket used personally by the official if he/she is attending in a public role or in performance of some official duty (see attached guidelines). Otherwise, if the official attends in a non-public role, then the value of his/her own ticket should be included in the reported gift.
