The exceptions are codified at Section 2-11.1(t)(1)(a). Subsection "viii" provides that the Cone of Silence does not apply to [c]ommunications between a potential vendor, service provider or bidder and employees of the Department of Procurement Management or other department identified in the solicitation document as the issuing department. . . . "
