Ms. Webb:

You have inquired concerning whether it is permissible under the Count Ethic s Code for three Port employees to accept a complimentary cruise, including registration, cabins, receptions and meals in connection with an upcoming Florida Caribbean Cruise Association (FCCA) Platinum Meeting on board the *Disney Dream* scheduled for January 24-27, 2013. The FCCA is a non-profit trade association of which Port/Miami is a Platinum Member and pays an annual membership of \$10,000 to the FCCA. It is anticipated that during the cruise the Port employees will attend meetings and events relevant to their Port duties and the Port's operations, and engage in networking with other cruise industry members. The ship involved is owned and operated by Disney Cruise Lines, a county contractor at the Port/Miami, which is also a member of FCCA.

Although there is a prohibition in Section 2-11.1(w), Miami-Dade County Code, against the acceptance of travel and related expenses from County contractors, the latter section also contains an exemption from the prohibition for "travel expenses paid by other governmental entities or by organizations of which the County is a member if the travel is related to that membership." Under the circumstances described above, the latter exemption would apply to the upcoming FCCA cruise. Therefore, there is no prohibition to Port employees' acceptance of this cruise. It would be appropriate for the individuals involved to make proper disclosure of the cruise and ancillary benefits on the county gift disclosure form.
