Mr. Neal,

As we discussed last week, your work with Back to the Basics Basketball, Inc., is outside employment and, consequently, you must abide by the requirements outlined in the County Code at Sec. 2-11.1 (j) and (k).

This means that, in addition to obtaining permission to engage in work with Back to the Basics Basketball, Inc., you must file an "Outside Employment Statement" annually with the Elections Department indicating your income from Back to the Basics Basketball, Inc. Since you derive no income, you should indicate "none" or "zero" on the "Outside Employment Statement" and attach this email to the form.

As background, outside employment is considered any non-County employment or business relationship in which the County employee provides a personal service to the non-County employer that is compensated or *customarily eligible to be compensated*.

We understand that you are the founder and act as the executive director of Back to the Basics Basketball, Inc., a nonprofit organization. The organization offers afterschool tutoring and basketball instruction for monthly fees. Among your duties at Back to the Basics Basketball, Inc., you recruit coaches and pay them stipends for their services.

Although you do not take a salary for these services, this type of work is *customarily eligible to be compensated*. As such, your services are considered outside employment.
