Hello Carolina,

The six employees of the Housing Finance Authority (HFA) are no longer County employees and, consequently, are not required to comply with the County Code at Sec. 2-11.1 (i) regarding financial disclosure filings.

In a conversation today, Adela Garcia, HFA Trust Account Manager, advised me that as of February 2011 the six HFA employees withdrew from the County and began receiving their salaries directly from the HFA, not through the County payroll system. (For convenience, the HFA employees remain in the County Outlook directory and obtain insurance benefits by piggybacking on the County's insurance program.)

Please be advised that some HFA employees may be required to file financial disclosure forms under state law, *e.g.*, as purchasing agents with authority to purchase in excess of \$20,000 and/or as chief administrators.

HFA board members continue to be under the authority of the Board of County Commissioners. *See* County Code at Sec. 2-191.8. Consequently, HFA board members are responsible for filing financial disclosure forms under the County Code at Sec. 2-11.1 (i).
