Mr. Gonzalez,

Under the County Ethics Code at Sec. 2-11.1 (w), you may accept two round-trip airline tickets from the Florida Customs Brokers & Forwarders Association (FCBF), a nonprofit trade association. The Miami-Dade County Airport and Seaport Departments are members of the FCBF, but you are not a member personally, and the FCBF is not a County contractor, vendor, service provider, bidder, or proposer.

Avianca Airlines, which is a County contractor, donated the airline tickets to the FCBF. The FCBF maintained exclusive control and possession of the tickets until you obtained them directly from the FCBF in a random drawing held on April 27, 2013.

The rationale for this opinion is based on your having obtained the airline tickets from a third party that is not a County contractor and that County employment was of no significance for participating in the random raffle.

You stated that you will disclose the gift of the airline tickets, valued at the price of unrestricted coach fares, in the quarter following the quarter in which you received them. This means that because you received the tickets in the second quarter of 2013, you must file a gift disclose form no later than September 30, 2013, the last day of the third quarter of 2013. *See* County Code at Sec. 2-11.1 (e)(4).
