Mr. Cameron,

The County Ethics Code at Sec. 2-11.1 (e)(2)(e) allows the County to accept gifts "for use solely by the County in conducting its official business."

You stated that Florida Cremation Services wishes to donate two body lifts to the County Medical Examiner Department. Len Sumlar, the Medical Examiner's morgue bureau manager, inspected the equipment and reported that these two lifts would be put to good use in your department. Consequently, as long as Florida Cremation Services is making the donation without any expectation of any favorable action in return for the donation, this gift may be accepted.

Equally important, because your department interacts daily with funeral homes and cremation facilities, including Florida Cremation Services, you and your staff must be vigilant in not extending any special advantages or benefits to Florida Cremation Services in response to this donation. (*See* ethics opinion RQO 05-119, which allowed the Village of Palmetto Bay to purchase a building at a price that was below market value as long as the Village Council did not extend any special privileges to the seller of the building were he to come before the Village Council in the future.)

You may wish to document receipt of the gift with a letter to the donor explaining that the County Ethics Code allows acceptance of the donation as long as no *quid pro quo* arrangement is envisioned.
