## Detective Vila.

As we discussed in May, <u>you have not received permission from this office to engage in outside employment</u>. Your letter (SEC 10-55) states that you do not have a conflict to contract with the County as a Section 8 landlord.

The Ethics Commission opines on Section 8 landlord contracts under Sec. 2-11.1 (c)(2) of the County Ethics Code, but outside employment is at the complete discretion of your supervisor under Sec. 2-11 (c) of the County Code and Administrative Order 7-1.

Because you rent 5 properties, <u>you must request permission from your department director or his/her designee to engage in outside employment every year</u>. Once you have obtained permission from your department director, you must file income statements related to outside employment with the Elections Dept. annually. *See* County Ethics Code at Sec. 2-11.1 (k)(2).
