Mr. Santorio,

You asked if the County Ethics Code applies to independent contractor-physicians at the Public Health Trust (PHT); this contractual arrangement is described in PHT Resolution 08/07-067 and is referred to as an "agency model."

Contractor-physicians under the agency model are generally not subject to the County Ethics Code because they are not employees of the PHT or Jackson Health System (JHS) and they have not been designated by the PHT as "contract staff" required to comply with certain provisions of the County Ethics Code. *See* County Ethics Code at Sec. 2-11.1 (b)(13).

In a related opinion, the Ethic Commission held that the County Ethics Code did not apply to physicianemployees of the University of Miami who contracted with the PHT unless these contractor-physicians were performing roles usually assigned to County personnel, such as serving on a PHT/JHS selection committee. *See* RQO 06-46, to Benedict Kuehne.

Consequently, JHS may purchase the assets of a contractor-physician's practice and enter into related leases without obtaining a waiver from the PHT, as would otherwise be required if the individual were a PHT/JHS employee. *See* County Ethics Code at Sec. 2-11.1 (b)(2).

Lacking this safeguard, you have taken other actions to protect the interests of the public, such as employing independent third parties to appraise equipment to be purchased and evaluate rental agreements. Additionally, independent contractor-physicians are subject to several professional codes including the PHT's procurement and conflict of interest policies, which, among other responsibilities, requires them to make decisions in the best interests of the PHT and the people it serves rather than their private interests.

Hi Victoria,

I read the conflict of interest prohibition under section. 2-11.1 (c) (1), (c) (2), and (d) to be applicable for county employees. Does this also apply to an agent of the TRUST? We have an agency model which is best described as follows:

- 1.) We acquire the assets of a physician practice through an asset purchase agreement.
- 2.) We enter into a Physician Services Agreement with the physician group to essentially lease their clinical services.
- 3.) We enter into a Management Services Agreement with the physicians in which we contract with them to continue running the practice for us.

The contracts explicitly state that the physicians are NOT employees, but rather, agents of the trust. The employees within that practice do not receive Jackson benefits and everything human resource wise and practice management wise is handled completely independent of Jackson.

In this scenario, would we have to have a waiver? The physician would essentially be leasing between his real estate management company and the agency. I know this relationship can be quite confusing so we can certainly discuss it on the phone if easier.
