You asked about certain limitations imposed by the Cone of Silence under the County Ethics Code at Sec. 2-11.1 (t).

Re: Proposer

A proposer *cannot speak* with County professional staff, including staff at the Community Information and Outreach Department (CIAO), to assist in developing his proposal or to discuss how the CIAO may be included in his proposal. *See* Sec. 2-11.1 (t)1.(a). These types of conversations may only be conducted at a duly notice public meeting or in writing, with a copy to the Clerk of the Board.

The proposer may request technical information from the CIAO in order to complete his proposal, as long as he limits these exchanges strictly to technical specifications only.

Re: The Homeless Trust

Ronald Book, the Chair of the Board of the Homeless Trust, may serve as a voting member on the selection committee to recommend a public relations provider, and he may also vote as the Chair of the Homeless Trust on the recommendation of the selection committee on which he serves.
