Based on information recently obtained from the County Grants Coordination Division, we are revising the ethics opinion given to you on June 25, 2013.

<u>Our revised opinion is as follows</u>: The County Ethics Code allows you, an employee of AYUDA, to rent property to AYUDA only if the Board of Directors of AYUDA waives the general ban against contracts between employees and their agencies. The Board of Directors must waive the prohibition by a 2/3 vote at a properly noticed meeting. *See* County Ethics Code at Secs. 2-11.1 (c)(4) and (d).

We understand that AYUDA, a community-based nonprofit organization, has a contract with the County to receive a County grant through the County's Community Based Organization (CBO) funds for three programs. The contract includes the following requirement:

ARTICLE 9. CONFLICT OF INTEREST

A. The Provider agrees to abide by and be governed by Miami-Dade County Ordinance No. 72-82 (Conflict of Interest Ordinance codified at Section 2-11.1 et al. of the Code of Miami-Dade County), as amended, which is incorporated herein by reference as if fully set forth herein, in connection with its contract obligations hereunder.

The County Ethics Code at Sec. 2-11.1 (d) prevents an employee, either directly or through an immediate family member, from contracting with her own agency. You stated that you have a rental contract with AYUDA at a price that is far below the fair market value. The County Ethics Code would allow you to continue with the rental contract if the Board of Directors of AYUDA waives the prohibition of by a 2/3 vote at a properly noticed meeting. *See* County Ethics Code at Sec. 2-11.1 (c)(4).

The County Ethics Code does not address whether you may enter into a leasing agreement with AYUDA, a
community-based nonprofit organization. AYUDA has received a County grant through the County's
Community Based Organization (CBO) funds for three programs. You have no affiliation with Miami-Dade
County.

I recommend that you review the contract between AYUDA and the County to determine if the contract provisions prevent a leasing agreement between you and AYUDA. Other conflicts of interest may exist under your nonprofit bylaws or federal codes regulating nonprofit entities.

- Our Contract Manager, Adolfo A. Leon, has asked us to obtain an written opinion from the Commission of Ethics and Trust.
