The Ethics Commission's jurisdiction is limited to issues arising under the County's Code of Ethics ordinance or Citizen's Bill of Rights. It does not extend to Robert's Rules of Order. In the event that someone improperly broke the rules in order to gain some personal profit or advantage, then it could potentially involve an ethics matter.
