**Subject:** Ethics Opinion (INQ 13-17)

## Councilman Fiore,

We find no ethics conflicts are created under the County Code when you and John Dubois serve concurrently as elected officials on the Palmetto Bay Village Council, and at the same time, you are employed by Camillus House and Mr. Dubois is a board member with Camillus House.

Based on the functional organization of Camillus House, Mr. Dubois's service on the Camillus House board while you are employed there is not likely to impair your independence of judgment in the performance of your public duties to the Village of Palmetto Bay. *See* the Miami-Dade County Code at Sec. 2-11.1 (j).

The 49-person board of Camillus House, of which Mr. Dubois is a member, does not oversee the hiring, firing, or supervision of employees. You were hired in December 2011 by the President of Camillus House, Dr. Paul Ahr, who has sole authority to manage the day-to-day operations of Camillus House. Typically, the board meets quarterly and has no substantive interactions with Camillus House employees. These facts were confirmed in a telephone conversation on Jan. 30, 2013, with the attorney for Camillus House, Roberto J. Diaz of J. Patrick Fitzgerald & Associates, Coral Gables.

At the time you were hired, Mr. Dubois had not yet qualified as a candidate for, nor had he been elected to, his current position as Vice Mayor on the Village Council.

As you are aware, the County Ethics Code establishes a minimum standard of conduct for public officials. It does not directly address "appearance of impropriety" issues that should guide the actions of all public servants, nor does it address the subjective mindset of an elected official who, for reasons outside of the Code, might not feel capable of being fair or objective in a particular matter due to personal considerations. Any elected official under these circumstances must use his own judgment in determining his proper course of action in executing his public duties.

Finally, we caution you that in the unlikely event you and Mr. Dubois were to encounter each other at Camillus House, a discussion between the two of you related to village business might violate the Sunshine Law at Fla. Stat. 286.011 (2012).
