Ms. Ramos asked me to respond to your question about disclosing gifts as a board member of the Ronald Reagan Equestrian Center Council. The County Code requires board members to disclose gifts valued at over \$100 that have been transferred to them *without adequate consideration*. *See* the County Ethics Code at Secs. 2-11.1 (e)(1) and (e)(4).

In your case, as the Associate Vice President of Marketing & Creative Services for the Greater Miami Convention & Visitors Bureau (GMCVB), you provide adequate consideration when you attend functions as part of your employment obligation with the GMCVB. Therefore, community events, lunches, and dinners valued over \$100 and which you attend solely in return for rendering personal services to your employer are not considered gifts and need not be disclosed.
