## Mayor Kreps,

Mr. Centorino asked me to respond to your question about accepting employment with the United Health Group as an RN case manager working with the Medicaid population.

You are the Mayor of North Bay Village, and employees of the Village are provided insurance coverage through the United Health Group and its affiliate, Neighborhood Health Partnership.

If you accept employment with the United Health Group, you will be an employee of a Village vendor. As a result, several provisions of the County Ethics Code will apply to you, including the following:

- Sec. 2-11.1 (u)—your employment contract with the United Health Group must be made in the
  ordinary course of business, at arm's length, with no special terms based on your position as
  Mayor.
- Sec. 2-11.1 (f)—you must disclose your employment relationship with the United Health Group on a sworn statement filed with the Village Clerk.
- Sec. 2-11.1 (w)—you may not accept travel expenses from the United Health Group, including, but not limited to, transportation, lodging, meals, registration fees, or incidentals.
- Sec. 2-11.1 (d)—you cannot vote on any matters affecting the United Health Group.

As you know, the County Ethics Code represents a minimal standard of conduct for elected officials. Consequently, in order to avoid even appearances of impropriety, we recommend that you carefully consider the totality of the circumstances before taking any official actions related to the United Health Group and its affiliates.
