Yes, you need to fill out the outside employment form. In fact, the requirement has been set for three or more rental "units" rather than properties. This is a rule that the Commission came up with sometime before I got here. You won't find it in the ordinance. It seems fairly arbitrary, but it was deemed necessary because at some point owning rental

properties is likely to take up as much time as a parttime outside job, so it was felt that employees should get permission and make the disclosure. Joe

Please know that we have always reported the other two properties in my annual financial disclosure. They are owned jointly, and neither of us takes a salary; we report them as a revenue source.

Sorry to bug you with this, but figured I go straight to the horse's mouth. Want to make sure I am doing whatever I need to be doing.
