Mr. Chavez.

Based on the facts you presented, your voluntary, nonpaid board service on the Board of Directors of the National Association of Elevator Safety Authorities International (NAESAI) does not create a conflict of interest for you under the Miami-Dade County Ethics Code.

NAESAI is a nonprofit 501(c)(6) entity and one of three national organizations that provides instruction and testing to certify elevator inspectors. Most County employees in the Office of Elevator Safety have been certified by NAESAI. As a board member, you would provide oversight to NAESAI related to fulfilling its mission, but you would not be involved with its day-to-day operations or routine interactions with candidates for licenses.

Because voluntary, nonpaid board service with a nonprofit entity is generally not considered "outside employment" as defined in the Miami-Dade County Code at Sec. 2-11, your board service is not subject to the prohibition against conflicting employment found in the County Ethics Code at Sec. 2-11.1 (j).

Nevertheless, you have agreed that you would recuse yourself from any matters coming before the NAESAI board that might conflict with your duties to the County. For example you would not sit on a NAESAI committee to hear a complaint against a County employee. (This would also be prohibited under NAESAI's ethics policy.)

NAESAI is a private non-profit association of inspectors and other stakeholders, and is the entity that issues credentials to individual members certifying that they are qualified as elevator inspectors, after having had their curriculum -vitae properly evaluated, and having passed an extensive written examination of their knowledge of the elevator codes, electrical codes, and other safety standards applicable to the elevator industry. They continue to certify the individual, and require that person satisfactorily pass a written re-certification examination annually. There are three such entities within the US who issue such credentials, NAESAI being the oldest and largest of the three.

Their Board of Directors is comprised of a certain percentage of private inspectors, and another percentage of inspectors from the government sector. The Board member does not represent their employer, but they are there because of their employment association. If I retired from the County, if I were I elected I would have to resign my position with the board as I would no longer be an AHJ member, unless I went to work for another AHJ like Miami Beach as an example. My leaving the Board does not automatically entitle Miami-Dade County to a seat on the Board, but anyone with an AHJ may run for that vacant seat. However, there can only be one board member per organization. It would be somewhat akin to the Bar Association Board of Directors, if they were required to have a certain percentage of membership from governmental agencies, certain percentage from corporate law firms, and a certain percentage of private practitioners.
