## Ms. Rodriguez,

You asked if you would be in violation of the County Ethics Code if you advertised the participation of your private company in a County-sponsored event on Oct. 18, 2013, where you will be donating 20% of the profits you earn at the event to support the United Way and Breast Cancer Awareness.

Although you do not appear to be exploiting your official County position for your personal gain, nor do you appear to be engaged in conflicting outside employment, your activities may create an *appearance* of self-promotion to the detriment of the County.

The County's Administrative Order AO 7-1 states, "County business must be conducted free of the influence of employees' personal and private financial interests, both *in appearance* and in fact." *See also* Miami-Dade County Code at Secs. 2-11.1 (g) and (j).

You stated that the Mayor's office invited your privately owned company, Healing Hands by Helen, Inc., to offer discounted chair massages at the Oct. 18<sup>th</sup> event. You agreed to donate 20% of your profits that day to the United Way and Breast Cancer Awareness. You have received permission from your department director and supervisors to engage in outside employment, to be absent from your County job on this day, and to use annual leave for your absence.

You personally created a flyer announcing the discounted massages, and the flyers were distributed electronically to all but one of the County's departments through the Mayor's office. The one exception to the distribution from the Mayor's office was in your own department, the Dept. of Regulatory and Economic Resources, where you distributed the flyers as part of your responsibilities as the United Way and Breast Cancer Awareness coordinator.

Going forward, in order to avoid an appearance of impropriety, you may wish to delegate—to another County department or County employee not associated with you—tasks related to developing and distributing flyers that promote your private services and products at County-sponsored events. Information and distribution about your private company should be kept to an absolute minimum.

## Ms. Frigo:

Good morning. I've been advised by Marcia Melendez to contact you regarding Conflict of Interest/Inquiry as to working to raise funds for the Making Strides Against Breast Cancer/United Way of Miami-Dade through my massage therapy company, Healing Hands by Helen, Inc.

Just so you know, I do have an Outside Employment which has been approved by our Department Director back in April of this year once I opened my company.
