Hello Christine,

As we discussed last week, a County employee who is the president of the Fulford Methodist Church cannot appear before the County's Environmental Quality Control Board (EQCB) seeking a variance or an appeal on behalf of the church. Additionally, the County employee cannot contact County personnel in an attempt to influence the ruling. The church is considered a "third party" as per the Miami-Dade County Ethics Code at Sec. 2-11.1 (m)(1).

Because the EQCB rules require that the president or vice-president of a corporation (or an attorney) represent the property before the EQCB, the vice-president of the Fulford Methodist Church (as long as s/he is not a County employee) or an attorney must present this case to the EQCB. Also be advised that the County employee who is president of the church cannot benefit financially, either directly or indirectly, for the services rendered by the vice-president or an attorney.
