You have inquired whether serving as a volunteer board member for the Broward County Consumer Protection Board (BCCPB) would create a conflict of interest with your employment as a County contract development specialist with the Department of Regulatory and Economic Resources. You advise that your current job responsibilities include reviewing all contracts issued by the County in order to determine opportunities for small businesses. You further advise that your role as a board member in BCCPB would include reviewing consumer complaints and addressing consumer grievances in Broward County. The County Ethics Code does not prohibit you, from serving as a member of the BCCPB in a volunteer capacity.

Sec. 2-11.1 (j) of the County Ethics Code prohibits County employees from engaging in certain activities that would impair their independence of judgment in the performance of their public duties to the County.

We concur with your supervisor that you are unlikely to be confronted with issues on the Broward County Consumer Protection Board that would impair your judgment or divide your loyalties as a County contract development specialist. Thank you for bringing this question to our attention and for your volunteer service in your local community.
