Ms. Mankes-Goldstein,

I am very troubled that our agency has been asked to give ethics advice based on misrepresentations and ambiguities. Opinions based on falsehoods are not legally binding.

First we were told that "one of the shareholders" of AMAJ Enterprise Corp. is "on" the Miami-Dade Homeless Trust, which gives the impression that someone other than Ms. Brown is "on" the Board of the Homeless Trust.

Next, Ms. Brown states that this "shareholder" is an "employee" of the Homeless Trust.

Now we are told that there is no group of *shareholders*, only the principal, Ms. Brown, who is an employee of the Homeless Trust.

If this last set of facts is true, these are the rules for County employees seeking a grant from the County:

- Ms. Brown, as an *employee* of the Homeless Trust Department, cannot accept a grant if the Homeless Trust Department is involved in any way in processing or administering the grant. (County Ethics Code at Sec. 2-11.1 (c)(2))
- Ms. Brown, as an *employee* of the Homeless Trust, may not lobby any County Department or Agency, including the office of Commissioner Sally Heyman, for the grant. This means that Ms. Brown may not contact anyone, in any manner or by any means, within the County (or anyone working on behalf of the County) *in an attempt to influence a decision about the grant she is seeking*. (County Ethics Code at Sec. 2-11.1 (m)(1))

Submitting a routine application, accepting payments, and turning in invoices, without attempting to influence an official decision, is *not* lobbying.

I trust that this third opinion accurately reflects the facts in this matter, but I am gravely concerned about the credibility of the person or persons who submitted information to this agency throughout this process.

Dear Ms. Brown:

Margot Mankes-Goldstein, an aide to Commissioner Sally Heyman, asked on your behalf if the County Ethics Code would prevent your privately owned company, AMAJ Enterprise Corp., from accepting a Mom & Pop Grant in light of one of your shareholders being *an employee* of the Miami-Dade Homeless Trust.

Briefly, your company may accept a grant as long as the *employee* of the Homeless Trust Department is not involved in any way in processing or administering the grant. Additionally, the employee of the Homeless Trust may not lobby for the grant. (*See* the County Ethics Code at Secs. 2-11.1 (c) and (m)(1).)

Be advised that the County Ethics Commission has interpreted lobbying very expansively when applied to County employees. This means that the County employee may not contact anyone within the County (or anyone working on behalf of the County) in an attempt to influence his/her decision about the grant you are seeking.

This opinion construes the Miami-Dade Conflict of Interest and Code of Ethics Ordinance only and is not applicable to any conflict under state law. Inquiries regarding possible conflicts under state law should be directed to the State of Florida Commission on Ethics.

Dear Ms. Brown:

Margot Mankes-Goldstein, an aide to Commissioner Sally Heyman, asked on your behalf if the County Ethics Code would prevent your privately owned company, AMAJ Enterprise Corp., from accepting a Mom & Pop Grant in light of one of your shareholders being a board member of the Miami-Dade Homeless Trust.

The County Code at Sec. 2-11.1 (m)(2) prohibits a County board member from making a presentation or seeking any benefits for himself/herself or others from the board on which he/she serves. Sec. 2-11.1 (c)(3) prohibits a County board member from entering into a contract with the County if the board on which he/she serves would oversee the contract. Sec. 2-11.1 (v) prohibits a County board member from voting on any matter affecting an entity in which he/she has a financial interest if he/she would be directly affected by the vote.

Since the Miami-Dade Homeless Trust would not be involved in any aspect of the Mom & Pop Grant being provide through Commissioner Heyman's District # 4 office, you have no ethics conflicts under the County Ethics Code based on the facts you presented.

This opinion construes the Miami-Dade Conflict of Interest and Code of Ethics Ordinance only and is not applicable to any conflict under state law. Inquiries regarding possible conflicts under state law should be directed to the State of Florida Commission on Ethics.
