With regard to our specific issue, it is your opinion that a member of a City board who is not a member of the professional staff of the City or its Community Redevelopment Agency, who is not a member of the City Commission or its Agency who has solicited the bids, who is not a member of the selection committee and who is not a bidder or a potential bidder/vendor, would not be one of

the persons who is prohibited from conversing with a member of the selection committee concerning the bids during the time that the Cone of Silence is in effect.

It is also my understanding that, notwithstanding this opinion, the safest thing to do is to not discuss the matter with anyone.
