### Hello Michelle.

As we discussed today, the individuals who serve as proxy board members for the Homeless Trust must file financial disclosure forms for the years during which they were able to participate—even if they did not actually participate that year.

This opinion is based on a recent holding by the Ethics Commission that requires County advisory board members to file financial disclosure statements regardless of whether the board on which they serve has met during the previous calendar year. *See* Ethics Opinion RQO 13-01 and Miami-Dade County Code at Sec. 2-11.1 (i).

The Ethics Commission reasoned that because individuals are approved and authorized to serve in an advisory capacity during any given year and because they may be subjected to undue influences as a consequence of their potential service, these individuals must file financial disclosure statements by July 1st following each year during which they were eligible to serve on the board.
