Robert M. Taylor, Senior Vice President of CBRE, has a conflict of interest to serve on the selection committee that is evaluating proposers for the hotel management contract at the Airport.

The County Ethics Code at Sec. 2-11.1 (j) states that a selection committee member must not have other employment that would impair his independence of judgment in the performance of his public duties. The fact that Mr. Taylor has a current contractual relationship with Driftwood Hospitality argues against his being able to make an independent decision about Driftwood's competence as a bidder on the Airport contract.

We do not wish to imply that Mr. Johnson would not perform his responsibilities properly. Rather, the conflicting employment standard aims to be preventative in nature, particularly when an individual's personal or private financial interests are involved.
