Good afternoon Victoria,

As we start preparing for the first financial disclosure mailing required at the end of May 2013, we are evaluating different ways to make the process a little more efficient for the filers and find ways to possibly reduce costs associated with this mailing on our end. One of the options up for discussion is whether we can send County Employees (with a county FD requirement) and County Board Members only a pre-printed Source of Income form for their use, and reference in the cover memo their option to file one of the three forms. Below is a preliminary draft of how we would modify the cover memo to inform these filers.

Before we entertain this option any further,

we wanted to check with you if this would be okay from a COE perspective. The idea came up since the majority of County Employees and County Board Members end up filing a Source of Income (the simpler and shorter county form); in some instances, the presence of a lengthy state Form 1 made filers question which form to file or wait until later in the year to submit a form. If the option of not including a six-page pre-printed Form 1 in the package is a viable option, we would be able to reduce our printing/postage expenses to mail the 6 extra pages (that would be 50% less pages) and we would hopefully minimize filer confusion by only providing one form to fill out.

I have attached a sample copy of last year's packages to give you an idea what filers typically receive from our office. In terms of figures, we typically mail out packages to about 2,000 State Local Officers (state FD requirement), 1,000 County Employees (county FD requirement), and 1,000 County Board Members (county FD requirement). When you can, kindly let us know your thoughts, thanks.
