## Mr. Otero:

I have reviewed your request and additional information regarding the upcoming Public CIO Technology Summit that is being sponsored by Government Technology, a private magazine publishing company, which provides a free subscription service of professional journals for government. It is not a lobbyist, vendor or contractor in the county. The summit is being held at the Ritz Carlton Biscayne here in Miami-Dade county. The event is by invitation only, which appears to suggest that there is no registration fee or other charge for attendance. The company has offered to pay for meals and a two night stay for you to attend the event. There will be no travel cost inasmuch as the event is taking place locally. The event will primarily benefit the company, which will have access to governmental decision makers for input into its informational resources. Your attendance at this event is not required by the county, and comes as a result of an offer from a private entity. There will, however, be some ancillary benefit to the county from your attendance in that you will have an opportunity to network with other government IT personnel and to gain perspectives on IT policies. There is no apparent nexus between the company's offer and any benefit they are seeking from the county.

Based on the information you have provided, there is no prohibition to your accepting the meals and hotel expenses offered for this Summit. However, it is my opinion that the provisions of a complimentary hotel stay, as well as meals for this event, does amount to a gift pursuant to Section 2-11.1(e) of the County Conflict of interest and Code of Ethics Ordinance. Therefore, in the event that you accept such benefits and the value of those benefits exceeds \$100, then you would be required to file a quarterly gift disclosure form with the County Clerk disclosing those benefits pursuant to Section 2-11.1(e)(4) of the Code. If there is no registration fee for the event, and you would be attending in your county capacity, you would not have to include an admission or registration charge in your disclosure form since your mere attendance at the substantive part of the invitation-only event would not constitute a gift. Also, under such circumstances, if you were to decline the hotel accommodations and meals, or if you only accepted meals valued less than \$100, then you would not need to file the disclosure form.

- why are they paying for a county employee to attend this? This is just conjecture on my part but I suspect that they need the participation of Government leaders and decision makers in order to have information for viable articles which serve to assist other governmental agencies.
- It would also be helpful to know why it is necessary for him to attend, or what benefit the county is getting from this. – It is not necessary to attend, however, attending will provide the County executive with the ability to network with other government decision makers, on what issues they face, how issues were solved, what works best for them in the IT arena, etc. It provides an opportunity to look at a fresh and external perspective on issues that face all us in public service IT at a relatively low cost (the employee's time).
