## Mr. Annunziato:

You have inquired on behalf of Commissioner Esteban Bovo regarding whether a newly-appointed commission aide to Commissioner Bovo, Daisy Castellanos, may continue to serve as a member of the City of Hialeah's quasi-judicial planning and zoning board.

Inasmuch as a Commission aide is not considered to be a county officer, Ms. Castellanos would not be required to resign her position pursuant to Section 99.012, Florida Statutes. Additionally, there is no provision of the Miami-Dade County Conflict of Interest and Code of Ethics Ordinance that would prevent her from serving in both position.

As a general matter, I would advise that she avoid dealing in her county position with any issue that could foreseeably come before her as a member of the Hialeah Board, in order to avoid possible Jennings rule violations, Conflicting Employment under Section 2-11.1(j) or any appearance of impropriety.
