#### Ms. Cordova-Jimenez:

You have inquired regarding whether the appointment of Mr. Alberto Latorre as a member of the Competitive Selection Committee for the Westchester Cultural Arts Center project, overseeing the procurement for Architectural and Engineering Services for this project, would create a prohibited conflict of interest. The Westchester Cultural Arts Center is a project under the oversight of the County's Cultural Affairs Department, which is assembling the selection committee. Mr. Latorre has his own architectural firm, which has participated in art projects at Miami International Airport, under which his firm has partnered with a firm owned by Carlos Betancourt, to contract with the County's Cultural Affairs Department, an arm of which, Art in Public Places, oversees art projects on County projects. It is Mr. Betancourt's firm name, not Mr. Latorre's firm, which actually appears on contracts with the County, but Mr. Latorre has participated in creating and presenting the proposals, and has acknowledged that he is a partner on the project in all other respects.

The Westchester Cultural Arts Center project will have an arts element involved, but the Art in Public Places arm of that department, which directly oversees such projects, is not involved in the procurement process for the A& E contract or the oversight of the that contract.

Inasmuch as Mr. Latorre is involved in pending contracts at MIA with the Cultural Affairs Department, the same department that is assembling the selection committee for the Westchester Cultural Arts Center, it is my opinion that Mr. Latorre should not serve on the selection committee due to a conflict of interest under Section 2-11.1(j) of the

County Ethics Code. It is likely that his independence of judgement could be impaired in a situation where he was serving under a county department in the selection process on one project, which being under the oversight of the same department in a contract he was working on in another County department.

CUA does indeed oversee the AIPP Program, however, CUA does not select nor approve the artists that are contracted under the Program. When a need for art in public places arises CUA (1) releases a Call-to-Artists in order to obtain submittals for said work, and (2) puts together a Professional Advisory Board (composed of local and national volunteer members from the art industry) to evaluate the submittals resulting from the Call-to-Artists. The Professional Advisory Board members, none of which is employed by CUA, short-lists artists and invites those short-listed to oral presentations. Upon completion of oral presentations the Professional Advisory Board makes a selection recommendation to the AIPP Trust who ultimately approves the recommendation for selection. The AIPP Trust is comprised of volunteer members appointed by the Board of County Commissioners who are not employed by CUA. CUA is staff to the Advisory Board and AIPP Trust, but does not have any selection or approval authority regarding the artists chosen to provided services under the AIPP Program.
