Det. Aquino:

You have inquired concerning the ethical propriety under the County Ethics Code of the practice of soliciting gifts from local groups or businesses in connection with recognition provided to an "Officer of the Month" by the Homestead Police Department. Section 2-11.1(e)(3) of the County Ethics Code prohibits public employees of the county or municipalities from soliciting any gifts. There is an exception in the Code under Section 2-11.1(2)(c) for the acceptance of awards for professional or civic achievements. However, I do not read this provision as permitting the solicitation of such gifts. In the event that a private organization or business entity should decide to initiate an award program or other special recognition for an officer, I would regard that as coming within this exception. However, a program that is initiated from within the department that provides special benefits to particular officers, and which involves solicitation of gifts from local businesses or other groups, would not qualify for this exception.
