Mr. Delgado:

You have inquired regarding whether it would be permissible for employees of Miami-Dade County Transit Department to participate in an out-of-town training session on products used by the County in transit buses. The training is being provided by Allison Transmission Company, the manufacturer of the products in question, which are purchased by the County through approved distributors of Allison products. Allison would be paying for travel and lodging expenses for the County employees. You have indicated that no products or services are purchased by the County directly from Allison, and that any existing contract for the purchase of Allison products occurs solely through the distributors. Allison is available to answer questions and provide assistance concerning the use of its products, but does so without any charge and without any contract for same with the County.

Section 2-11.1(w) of the Miami-Dade County Conflict of Interest and Code of Ethics provides that no county official or employee "shall accept, directly or indirectly, any travel expenses, lodging, meals, registration fees and incidentals from any County contractor, vendor, service provider, bidder or proposer." Under the circumstances recited above, it appears that Allison Transmission Company does not fall within the parameters of this ordinance since it is not a County contractor, vendor, service provider, bidder or proposer. Therefore, I have concluded that employees of your department may attend the training session being provided by Allison where certain travel and lodging expenses are being borne by Allison. I would caution you, however, that if any portion of the expenses for this event are being borne by any of the distributors of Allison products that do business with the County, or by any other company having a contract with the County for the provision of products or services, then this opinion would likely be different.
