Dear Mr. Sinkes:

It was a pleasure speaking with you. You have inquired if you would be required to obtain permission to engage in outside employment when you own a private business which you supervise, but which currently is not generating income.

As background, you are an employee of the City of Miami Beach. You also have an active private electrical contracting business which you manage (pay bills, fees, taxes and insurance) but which is not currently generating income.

In previous opinions the Ethics Commission has found that outside employment activities include providing a personal service to one's own business (secretarial, bookkeeping, marketing, paying bills, etc.), regardless of whether the business is officially incorporated, or if incorporated, regardless of the jurisdiction in which it is incorporated, or regardless of whether the business is currently generating income. *See* INQ 13-34 and INQ 12-131.

The test for whether an activity constitutes outside employment is not ownership or receiving actual compensation but rather if the employee performs a personal service for the business that is customarily compensated. *Id.* Consequently, providing personal services to your privately owned business such as bill paying and performing other activities required to maintain the business active, are services that would customarily be compensated and would be considered outside employment.
