Dear Mr. Payne:

It was a pleasure speaking with you. You have inquired if you would be required to obtain permission to engage in outside employment where you provide human resource consulting services to a closely held family business.

As background, you advise that your wife is part owner of a closely held privately owned business. You serve as a board member for the corporation and also provide human resources consulting services to the corporation.

Please note that outside employment is defined as any non-County employment or business relationship in which the County employee provides a personal service to the non-County employer that is *compensated* or *customarily eligible to be compensated*. See INQ 13-34 and INQ 12-131. Therefore, the question is not whether the employee is receiving or not receiving income, but whether the employee is *providing a personal service*. Id. Providing human resource consulting services is a personal service that is customarily compensated and would consequently be considered outside employment which would require completing the <u>Request for Outside Employment</u> form yearly and filing the <u>Outside Employment Statement</u> form by July first. See County Code at Section 2-11.1(K).
