Dear Ms. Campos:

You have inquired whether a conflict of interest would exist where an employee of the Miami-Dade Aviation Department (MIA) has requested permission to engage in outside employment providing airport leasing consulting services for a business consulting firm that is not a County vendor or tenant.

As background, Mr. Eli Mizrahi is employed by MIA as a Senior Property Manager administering leases for the Airport Terminal Building. Mr. Mizrahi does not solicit or select current or potential airport tenants; he is not responsible for the assignment of lease spaces or for the drafting or negotiating of lease documents or lease terms. His job responsibilities include preparing standardized "boiler" plate agreements drafted and approved by the executive staff in consultation with County Attorneys and submitting these executed agreements to the County Attorney for legal sufficiency review and to the executive staff for approval.

He is seeking outside employment with Jacobsen/Daniels Associates, LLC (JDA), a Michigan company, which provides business consulting services throughout the Unites States and its territories. JDA is not currently a county vendor or a tenant at MIA or other County general aviation airports, and it is not anticipated that they will seek to become a County vendor or tenant in the foreseeable future. Mr. Mizrahi's job responsibilities for JDA would be limited to a single project involving the development of a document outlining best practices regarding airport leasing policies and procedures. His work hours for the JDA would occur on evenings and weekends, outside of his MIA work hours.

We have discussed this matter with Mr. Mizrahi's supervisor, and concur with her that Mr. Mizrahi's work for JDA is not closely related to the lease preparation function he performs in his County employment at MIA. The hours of employment with JDA would not conflict with Mr. Mizrahi's hours of employment at MIA, it would not involve work with a County Contractor, and it would not require him to lobby the County on JDA's behalf or to interact with County employees or boards on behalf of JDA. Under these circumstances, it is unlikely that this type of work would impair his independence of judgment in the performance of his County duties at MIA as a Senior Property Manager. *See* County Ethics Code at Sec. 2-11.1(j).

As a reminder, pursuant to the County Code at Section 2-11, County employees are required to request permission for outside employment from their supervisor (Request for Outside Employment form) on a yearly basis. The County Code at Section 2-11.1(k)(2) requires filing a financial disclosure form (Outside Employment Statement) on a yearly basis. In addition, County employees are cautioned that they may not engage in any activity which would require them to disclose confidential information acquired by reason of their official position, nor use such information directly or indirectly for their personal gain or benefit. *See* County Code at Sec. 2-11.1(h)
