Mr. Bryan,

You have inquired whether you may accept a paid trip (flight, hotel, registration) to Las Vegas from IBM to attend an IBM Conference, where you have been asked by IBM to assist in a presentation regarding the findings of a study done by IBM at Miami-Dade Transit, where you are employed as a Section Chief. If, as you seem to indicate, IBM is a current County vendor, then you may not accept this trip unless the County Commission waives the restrictions of Section 2-11.1(w) of the Miami-Dade County Conflict of Interest and Code of Ethics Ordinance. The latter ordinance provides that no County official or employee "shall accept, directly or indirectly, any travel expenses, including, but not limited to, transportation, lodging, meals, registration fees and incidentals from any County contractor, vendor, service provider, bidder or proposer." There is no exception applicable to your circumstances .This prohibition may be waived only by a majority vote of the Board of County Commissioners.
