Ms. Lucia Davis-Raiford, Director of the Miami-Dade County Department of Community Action and Human Services, inquired concerning her activity as an unpaid board member of the Carrie Meek Foundation, a non-profit organization, in connection with issues it may have with Miami-Dade County. This request was, in part, an attempt to seek clarification of a prior INQ issued by former COE Director Robert Meyers (INQ 09-33) which Ms. Davis-Raiford had interpreted as only limiting her from representing the organization in connection with grant funding by the County. Ms. Davis-Raiford was supplied with RQO 12-10, which indicates a much stricter standard for county employees under Section 2-11.1(m)(1), which prohibits an employee from appearing before any County board or agency to make a presentation on behalf of a third person "with respect to any license, rate schedule, franchise, or other benefit sought by the third person." Under the foregoing provision, Ms. Davis-Raiford would be prohibited from representing the Carrie Meek Foundation on any pending decision to be made by County personnel. Ms. Davis-Raiford, upon reviewing RQO 12-10, communicated that she understood the prohibition and would abide by it.
