## Miriam,

Based upon my review of the relevant ordinances and RQO 05-27, I see no problem with the use of the language referenced below, which requires respondents requesting professional references from Miami-Dade County employees to submit the request in writing to the attention of the County employee and with a copy to the Clerk of the Board. Regarding the issue of whether county employees may act as professional references, I do not think that is a problem under the Code provided that they are not being asked to make any recommendations concerning whether a particular firm should be hired. That could violate Section 2-11.1(p) of the code which restricts such recommendations by county personnel. It is permissible to provide a reference for a prospective contractor when the employee is doing so within the scope of his or her official duties. I do not think it advisable for a county employee to provide such references when the employee is serving on the selection committee making the decision.
