Mr. Do:

You have requested an opinion regarding a potential conflict of interest under the outside employment restrictions set out in the Ethics Code.

A background, you are employed as a Zoo Exhibits Technician at Zoo Miami. Your hobby is wildlife photography. On your days off, you have taken photos in the public spaces of Zoo Miami (Zoo). You advise that there is no prohibition under Zoo policies for individuals to take photos in the public areas of the Zoo. The designer of Events by La Vie (La Vie), a private company, is a friend of yours and has asked to use some wild life photos you took at Zoo Miami several years ago in the company's website to support a Safari 5K running/fitness event the company is hosting at the zoo in October 2014. You are not being compensated monetarily for any of the images, but La Vie will give you photo credit on their website for the images used.

Providing images you have taken in the public areas of Zoo Miami free of charge to an event company for use in their website would not constitute prohibited outside employment under the Ethics Code. See the Miami-Dade County Code at Sec. 2-11.1 (j). Further, under Section (j), providing these photos which you took several years ago is not likely to impair your independence of judgment in the performance of your duties to Zoo Miami. Consequently, in this case, no prohibited conflict would occur under the Ethics Code.
