> In response to your questions below, please be advised as follows:

> There is no ethical problem with county employees being involved in advocating for a political action committee such as CALM as volunteers on their own personal time. I have attached a memo that has been distributed in the past regarding political activities of public employees that describes the limitations on such activities. I suggest that you forward it to any county employees who may be involved in CALM's efforts. Use of county time or resources in furtherance of such activities could amount to Exploitation of Official Position under Section 2-11.1 (g) of the County Ethics Code.

>

> County employees appearing as individuals representing only themselves may advocate their positions before County agencies, and need not register as lobbyists, pursuant to Section 2-11.1(s)(3)(b). However, Section 2-11.1(m)(2) would prohibit county employees from engaging in any discussions whatsoever with officials, directors or staff of the county on behalf of a third party, even if they did register as lobbyists. Therefore, it would be important in any contact with the County that county employees not engage in any "lobbying" type activity as a representative, paid or unpaid, of another person or entity, and to be careful to state that they are representing only themselves. Non-county employees who hold official positions with CALM as officers or directors and appear without special compensation or reimbursement before the County as representatives of and on behalf of CALM should register as lobbyists, but are not required to pay registration fees per Section 2-11.1(s)(4). >
