You have inquired whether firefighters and employees of MDFR may accept the invitation of W.L. Gore, a county vendor to attend a training event that will include payment of airline tickets, hotel, shuttle and food at an out-of-state location. This training would be valuable for the MDFR employees attending.

Section 2-11.1(w) is very clear in prohibiting acceptance of "transportation, lodging, meals, registration fees and incidentals from any County contractor, vendor, service provider, bidder or proposer." The only way this can be avoided is for the Board of County Commissioners to waive the requirements of this subsection by majority vote.

In the event that MDFR feels that the public benefit from this training event is significant enough to apply for a waiver, then the appropriate recourse is to apply to the BCC.
