Victoria,

The question regarding whether a Commissioner and staff member would need to report a complimentary admission to the Beacon Awards dinner would come down to whether they are doing something affirmatively in their official positions during the event. Mere passive attendance is insufficient based upon the Ticket Policy and Addendum adopted by the Ethics Commission (see attachment). If there is a speech given or some active involvement or recognition of the official in the program, then that would suffice as a public purpose to take the event out of the gift category. The attached addendum provides further guidance in that regard. If a spouse or other guest is invited along with the official, then the complimentary admission for the guest is considered a gift to the official. If the admission for either or for the official and guest taken together is worth more than \$100, it should be reported.
