Good afternoon Ms. Correa,

You inquired whether a principal who lobbies on behalf of his or her company is required to register and attend the Lobbyist training/course.

A principal who engages in lobbying on behalf of his or her own company must register as a lobbyist and does not have to pay the lobbyist registration fee but must complete the Lobbyist Ethics training/course and pay the \$100 course fee. See 2-11.1(s)(3)(b) and (s)(2)(d) of the County Ethics Code.

I am attaching the "Lobbyist Frequently Asked Questions, 2014" for your information.
