Chip,

In response to your question regarding whether the two-year lobbying ban in Section 2-11.1(q) of the County Ethics Code for former County officials and employees includes the Public Health Trust, the answer is that it does include lobbying before the Public Health Trust since the PHT is part of County government, and is bound by all provisions of the County Ethics Code.

The two-year ban would also apply to anyone acting as a sales representative actively involved in selling products at the PHT or the County, since the Ethics Commission has included sales representatives under the definition of lobbyists per RQO 06-65.

The two-year rule would not apply to former County personnel employed by other governmental entities, 501(c)(3) non-profit entities, or educational institutions or entities and who lobby on behalf of such entities in their official capacities, per Section 2-11.1(q)(2).
