
Ms. Hernandez:

You have inquired on behalf of Attorney Tom Robertson regarding lobbyist training refresher requirements. Under Section 2-654(a) of the City of Miami Code, there is a requirement for yearly refresher lobbyist training following the completion of the initial Ethics Course provided by the Commission on Ethics. Under Section 2-11.1(s)(2)(d) of the Miami-Dade County Code, there is a requirement that the refresher training be completed every two years. We have interpreted this to mean that the initial training will be considered valid for the full year (Miami) or two year (Miami-Dade County) period. Since Mr. Robertson completed the initial training on October 28, 2015, he would not be required to complete a refresher course (assuming he wants to continue to lobby) until October 2016 for the City of Miami or October 2017 for Miami-Dade County.
